#### **Terms & Conditions**

All acts are required to return a signed copy of the Nebraskappella! Registration Terms & Conditions, that is included as part of the registration form.

#### **Mass Chorus**

All participating groups will join together to perform a predetermined song! More information, including the song(s), will be sent out over the summer.

#### **Risers**

The Kearney Area Barbershoppers will be providing (5) five, three level, chorus risers. If your chorus needs more, please indicate so on the registration form, and plan to provide the extra risers.

#### **Tickets**

The NSF will provide adequate complimentary gate admission passes for performers. Requested ticket numbers must be accurate, and cannot be rounded. Passes are for performers only. Passes will not be provided to non-performing members, managers, friends, family, or anyone else outside of the immediate performer(s) of the act. Tickets given out for this event will only be scannable on Sunday, August 29<sup>th</sup> for Nebraskappella! Day.

#### **Other Fair Information**

1. The sale of merchandise is permitted. The NSF requires 20% of all merchandise sales on the Fairgrounds, including that of performing artists. 2021 selected performers will receive a Merchandise Agreement, outlining the NSF's Merchandise Sales policy.
2. All acts must be family and fair friendly.
3. **Your performance(s) must stay within the scheduled time frame, to ensure our stages stay on schedule.**
4. The NSF does not provide travel, hotels, food, or alcohol.
5. All parking on the grounds is free. Convenient parking is not guaranteed.

Scheduling will take place in May and confirmation sent by the beginning of June. An informational packet including parking, performance instructions, ticket information, and more will be sent later this summer.

- ◆ The parties agree that the Act, and any agents and employees of the Act, are acting in an independent capacity and not as officers, employees, or agents of the NSF.
- ◆ Act hereby waives all claims and recourse against the NSF Board, Fonner Park Exposition and Events Center, The Hall County Livestock Improvement Association, and the City of Grand Island, including the right to contribution for loss or damage to persons or property in any way connected to this Application and any subsequent Agreement, and shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, The Hall County Livestock Improvement Association, and the City of Grand Island from all claims due to any acts or omissions.
