*All competing dogs entering the show grounds must be accompanied by a Certificate of Veterinary Inspection (CVI) issued within thirty (30) days by a licensed veterinarian, which states that the dog has been properly vaccinated for rabies. These CVI's will be checked at the Livestock Check In Trailer on Stolley Park Road, prior to entering the grounds.

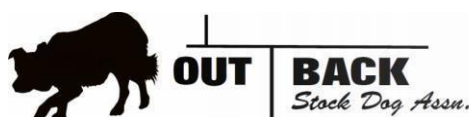
Open - \$65.00; Intermediate/Novice - \$50.00; Nursery - \$50.00; Collegiate - \$25.00;

Entry Deadline: AUGUST 10, 2019

The Nebraska State Fair Stock Dog Trials will be open to sixty (60) dogs for the qualifying rounds. **In the event entries exceed the limit, the first sixty (60) dogs entered by postmarked date, will be entered in the trials.** The top ten open dogs from the qualifying open round will advance to the Finals Tuesday night. The top ten (10) will be determined by the lowest sum of placing from both rounds. The overall winner in Intermediate/Novice, Nursery, and Collegiate will be determined by the lowest sum of placing over the two days. This will be a time and points trial incorporating Outrun, Fetch, Drive, and Pen Work. Course and rules will be explained at the handlers' meeting immediately preceding each day's event.

OUTBACK STOCKDOG ASSOCIATION MID-YEAR FINALS

20 Open class dogs, 10 Nursery dogs and 10 Intermediate teams which have earned points in Outback Stockdog Association (OBSDA) sanctioned trials are invited to participate in the OBSDA Finals. Entries will be accepted in order of points earned. One dog per handler. Classes may be filled by second dog per handler. Nursery and Intermediate Finals will be held Monday and Tuesday, respectively, following the regular trial. Open semi-finals will be held Monday evening. The top ten placing dogs from the semi-finals will advance to the OBSDA Finals on Tuesday evening immediately following the State Fair Finals.
