### 1. Entries

- a. All Nebraska State Fair Livestock Entries are online at <https://www.statefair.org/competitions/livestock-exhibitors>
- b. **Entry Fees (per day)**
  - i. \$65 for Open Division and \$50 for Novice, Nursery, and Intermediate Divisions.
  - ii. Designated livestock exhibitor parking areas will require a parking pass to be purchased. This parking pass can be purchased when completing online entries or at the check-in trailer.
- c. All entries must provide proof of current rabies.

### 2. Special Rules

- a. General Rules and Regulations and Health Requirements apply to this division as well as those rules listed below. By submitting entry to the Nebraska State Fair exhibitor agrees to abide by these rules.
- b. The Trials will be National Cattledog Association.
- c. The Nebraska State Fair Cattle Dog Trials will be open to 60 dogs for the qualifying rounds. In the event entries exceed the limit, the first 60 dogs entered will be entered in the trials.
  - i. The top twenty open dogs from the qualifying open rounds will advance to the Finals Wednesday night. The overall winner in Intermediate, Nursery, and Novice will be determined by results over the two days.
  - ii. This will be a time and points trial incorporating Outrun, Fetch, Drive, and Pen Work.
  - iii. The course and rules will be explained at the handlers' meeting immediately preceding each day's event.
